FISHIN' IN THE DARK CONTEST RULES

THE FISHIN' IN THE DARK CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. **ELIGIBILITY.**

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of Canada;
 - (b) be of the age of majority in their province or territory of residence or older at the time of entry; and
 - (c) be available to participate in the Event on June 12, 2024.
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of , Corus Radio Inc., operating as CFPG-FM (the "**Station**") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "**Corus**");
 - (b) Employees of Q Lake Lodge, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "Q Lake Lodge", together with Corus, the "Sponsors");
 - (c) Employees of Performance Promotions Ltd., its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
 - (d) Employees of Eliminator-RC, its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
 - (e) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below where the prize was valued over one hundred Canadian dollars (CDN\$100); and
 - (f) The household members of any of the parties listed in Section (a) to (e) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. **CONTEST PERIOD.** The Contest begins at 6:00 am Central Time ("CT") on May 24, 2024 and ends at 11:59 pm CT on June 6, 2024 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. **HOW TO ENTER.**

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter online, complete and submit the entry form located at https://country99.com/ (the "Contest Microsite").
- 3.2 Limit of one (1) entry per person, per e-mail address, per household during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZES.

- 4.1 There is one (1) grand prize (the "**Grand Prize**") available to be won by the Grand Prize winner ("**Grand Prize Winner**") consisting of:
 - (a) Three (3) nights hotel accommodation at the Q Lake Lodge or such other venue to be selected by the Sponsors in their sole discretion for the Grand Prize Winner and one (1) guest (the "Guest") based on double occupancy unless otherwise indicated; and
 - (b) Two (2) full weekend passes to Dauphin's Countryfest, including camping for the entire weekend on June 28, 2024 through June 30, 2024; and
 - (c) One (1) Super Cat RV Catamaran 700BL.
- 4.2 The Grand Prize has an approximate value of three thousand one hundred and fifty Canadian dollars (CDN\$3,150).
- 4.3 There are four (4) secondary prizes (each, a "Secondary Prize") available to be won by the Secondary Prize winners (the "Secondary Prize Winners"), each of which consists of:
 - (a) Two (2) general admission tickets to Dauphin's Countryfest; and

- (b) One (1) gift card from Eliminator-RC, with a value of forty Canadian dollars (CDN\$40).
- 4.4 Each Secondary Prize has an approximate retail value of three hundred and eighty-five Canadian dollars (CDN\$385).
- 4.5 Grand Prize and Secondary Prizes, are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner and Secondary Prize Winners, and are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.6 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.7 Prizes will be distributed within Five (5) days after each Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. **PRIZE CONDITIONS.**

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Grand Prize Winner and their Guest must be available to participate in the Grand Prize from June 28, 2024 to June 30, 2024. Should Winner and/or Guest be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.
- 5.2 Grand Prize Winner and Guest will be responsible for any other expense not explicitly included in the Prize including but not limited to transportation to and from hotel, taxes, gratuities, telephone calls, and in-room charges. Winner may be required to present a valid major credit card upon checkin at the hotel to cover any expenses over and above the standard room charge.
- 5.3 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.4 Guest must: *(i) be of the age of majority or older in their province or territory of residence; and (ii) comply with the Contest Rules and sign and return the Release (described below).*
- 5.5 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.
- 5.6 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

6. **QUALIFIER SELECTION.**

- 6.1 Five (5) qualifiers will be selected as follows:
 - (a) One or about June 7, 2024, five (5) entrants will be selected by random draw from all eligible entries received (each a "Qualifier", collectively the "Qualifiers"). The odds of being selected as a Qualifier are dependent upon the numbers of eligible entries received by the Sponsors. Before being declared a Qualifier, each selected Qualifier shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
 - (b) All Qualifiers must be able to participate in the fishin' in the dark event (the "**Event**") on or around June 12, 2024 at 4:00p.n. CT, at the Station.
 - (c) EACH SELECTED QUALIFIER WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN JUNE 7, 2024 AT 9:00 AM CT AND MUST RESPOND WITHIN THREE (3) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

7. WINNER SELECTION.

- 7.1 One (1) Grand Prize Winner and four (4) Secondary Prize Winners shall be selected as follows:
 - (a) On or about June 12, 2024 around 4:00p.m. CP in Winnipeg, Manitoba, the five (5) Qualifiers must attend and compete in the Event.
 - (b) Each Qualifier will be blindfolded and given a fishing rod. Qualifiers will have three (3) minutes to "catch" as many magnetic fish as possible. The Qualifier that catches the most magnetic fish in three (3) minutes, will be declared the Grand Prize Winner. The remaining Qualifiers will be declared the Secondary Prize Winners. In the case of a tie, the Qualifiers will be given another three (3) minutes to try and catch the most fish.
 - (c) Before being declared a Winner, each selected Qualifier shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release (described below).
 - (d) EACH SELECTED QUALIFIER WILL BE NOTIFIED IN PERSON NO LATER THAN JUNE 12, 2024 AT 7:00 PM CT AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified

- and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (e) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The executed Release must be returned within three (3) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.
- 9. **INDEMNIFICATION BY ENTRANT.** By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.
- 10. **LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.
- 11. **CONDUCT.** By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsite [and made available upon

request by self-addressed, stamped envelope to 201 Portage Avenue, Winnipeg MB R3C 0B9 throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Microsite or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. - 12.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with Q Lake Lodge for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
- 12.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.

- 14. **TERMINATION.** Subject to the jurisdiction of the Régie des alcools, des courses et des jeux in Quebec, the Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

- 15. **LAW.** These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- 16. **DISCREPANCY.** In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control. - 17. **FOR RESIDENTS OF QUEBEC.** Any litigation respecting the conduct or organization of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux for a ruling.
